### Project abstract:

Does regional exposure to civil conflict explain long-run local economic development patterns of regions in Africa? To address this question, this project will combine high-resolution spatial data on the location and intensity of conflicts since 1945 with night-time illumination across countries in Africa that experienced civil conflict. This project aims to investigate whether there exists a relationship between conflict exposure and contemporary local economic development. In addition, this project will explore whether there are variations in the effects of civil conflict on local economic development, and what factors or characteristics explain the heterogeneities in the effects of conflict across countries in Africa. The project seeks to contribute to the literature on legacies of civil war and drivers of local economic development.
